As citizens of the world, we should not only want freedom and human rights for the people within our own respective societies, but we must uphold the belief that all people are born equal, and deserve equal rights and dignity.

This is the true essence of what it means to be a citizen of a living democracy.

It is how we treat the weakest or most vulnerable members of our communities that shows who we are.

A society is at its strongest when it draws upon its diversity, and when it endeavours to ensure that universal human rights and fundamental freedoms are truly enjoyed by all.

This is the strength I believe that we must promote.

On concluding, I believe that we have a clear, ethical duty, to remind the world that our Mediterranean Region is not simply a place of tragedy.

The Mediterranean Region has always been, throughout the millennia, a place of welcome, of refuge, and of dialogue.

Let us work together, to ensure that this legacy of hope informs our future, as we work to overcome the challenges of our contemporary world.
